

LEGAL DESCRIPTION

THE LAND DESCRIBED HEREIN IS SITUATED IN THE STATE OF CALIFORNIA, COUNTY OF YOLO, CITY OF WEST SACRAMENTO, DESCRIBED AS FOLLOWS:

PARCEL ONE:

LOTS 19 AND 20, BLOCK 28, TOWN OF WASHINGTON, FILED JUNE 26, 1869 IN BOOK I OF DEEDS, AT PAGES 264 AND 265, YOLO COUNTY RECORDS, TOGETHER WITH THAT PORTION OF WESTERLY ONE-HALF OF SIXTH STREET VACATED BY RESOLUTION NO. 00-38, RECORDED JUNE 3, 2003, INSTRUMENT NO. 2003-0032007, YOLO COUNTY RECORDS.

EXCEPTING THEREFROM THE FOLLOWING:

BEGINNING AT THE NORTHEAST CORNER OF SAID LOT 19; THENCE ALONG THE EASTERLY LINE OF SAID LOT 19, SOUTH 6°33'30" WEST, 9.50 FEET; THENCE LEAVING SAID EASTERLY LINE, NORTH 80°56'15" WEST, 53.66 FEET TO A POINT ON THE WESTERLY LINE OF SAID LOT 20; THENCE ALONG SAID WESTERLY LINE NORTH 8°33'30" EAST, 16.50 FEET TO THE NORTHWESTERLY CORNER OF SAID LOT 20; THENCE ALONG THE NORTHERLY LINE OF SAID LOTS 20 AND 19, SOUTH 81°26'30" EAST, 53.20 FEET TO THE POINT OF BEGINNING.

BEGINNING AT A POINT IN THE EASTERLY LINE OF SAID LOT 21 THAT IS DISTANT SOUTH 8°33'30" WEST, THEREON 16.50 FEET FROM THE NORTHEASTERLY CORNER OF SAID LOT 21; THENCE ALONG SAID EASTERLY LINE, SOUTH 6°33'30" WEST, 63.50 FEET TO A POINT ON THE SOUTHERLY LINE OF SAID LOT 21; THENCE ALONG SAID SOUTHERLY LINE NORTH 81°26'30" WEST, 26.60 FEET TO A POINT ON THE WESTERLY LINE OF SAID LOT 21; THENCE ALONG SAID WESTERLY LINE NORTH 8°33'30" EAST, 60.00 FEET; THENCE LEAVING SAID WESTERLY LINE, SOUTH 88°56'15" EAST, 56.83 FEET TO THE POINT OF BEGINNING.






